هدف المؤتمر

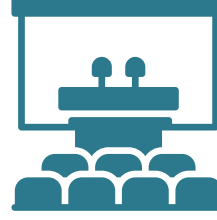

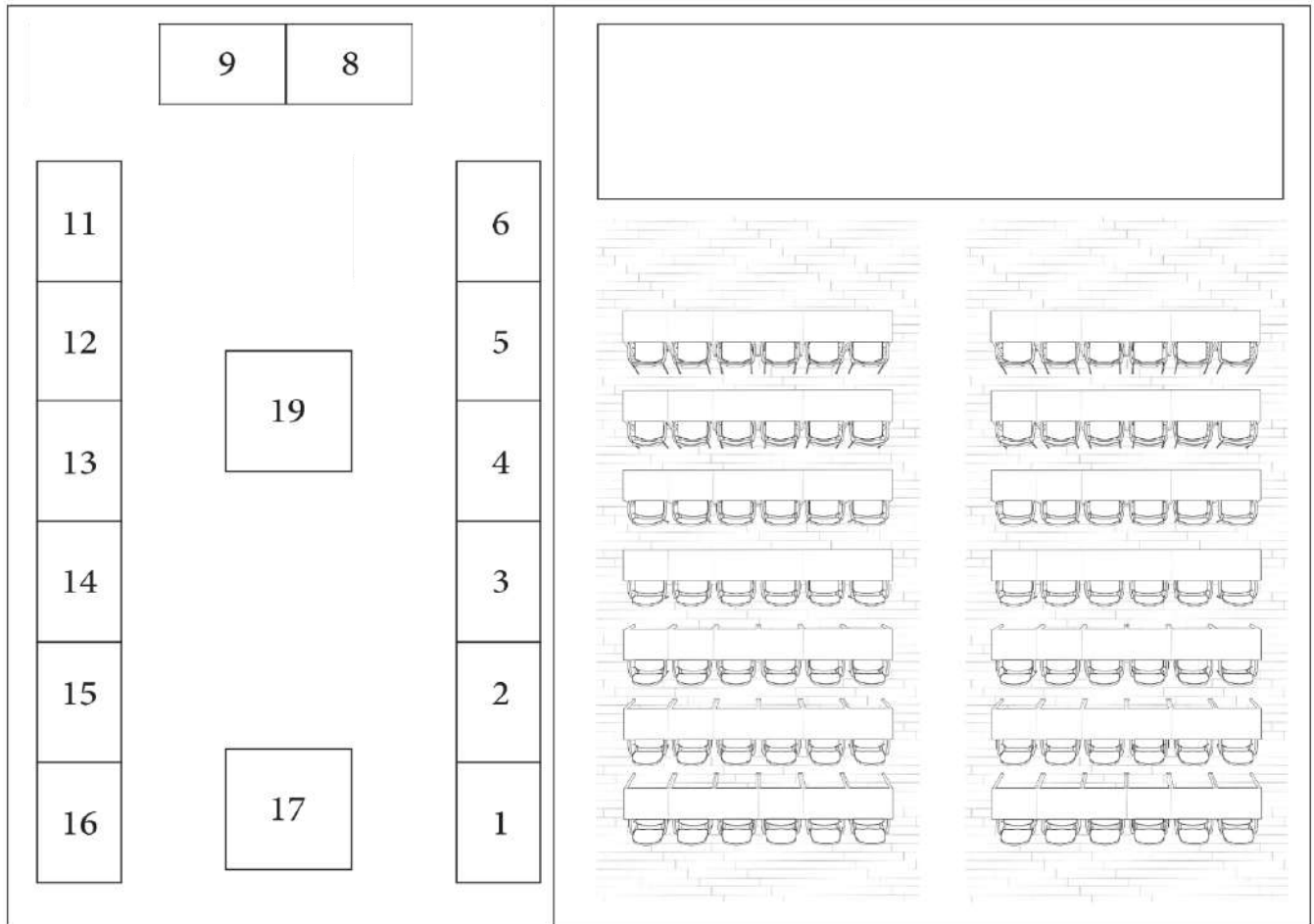
