Introduction:

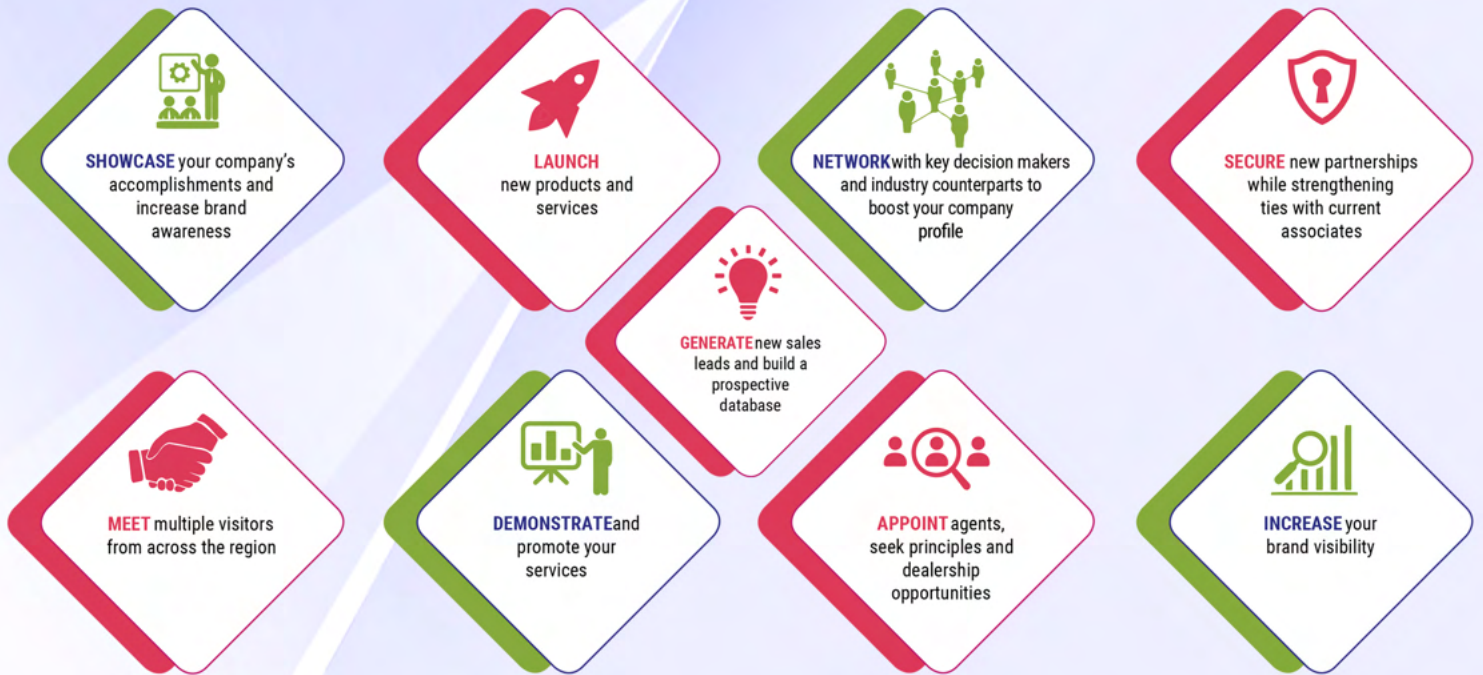
